

Federal Disaster Programs

FEMA PUBLIC ASSISTANCE (PA)

The Federal Emergency Management Agency's (FEMA) Public Assistance (PA) Program is FEMA's largest grant program. The PA Program provides funds to assist communities responding to and recovering from major disasters or emergencies declared by the President. The program also provides funding for emergency assistance to save lives and protect property and assists with funding to permanently restore community infrastructure affected by a federally declared incident. Eligible applicants include states, federally recognized tribal governments (including Alaska Native villages and organizations so long as they are not privately owned), U.S. territories, local governments, and certain private non-profit (PNP) organizations.

FEMA INDIVIDUALS AND HOUSEHOLDS ASSISTANCE (IHP)

The Federal Emergency Management Agency's (FEMA) Individuals and Households Program (IHP) provides financial and direct services to eligible individuals and households affected by a disaster who are uninsured or under-insured against necessary expenses and serious needs. IHP assistance is not a substitute for insurance and cannot compensate for all losses caused by a disaster. The assistance is intended to meet your basic needs and supplement disaster recovery efforts.



IHP Assistance may include:

- Funds for temporary housing while you are unable to live in your home, such as rental assistance or reimbursement for hotel costs.
- Funds to support the repair or replacement of owneroccupied homes that serve as the household's primary residence, including privately-owned access routes, such as driveways, roads, or bridges.
- A temporary housing unit, if approved for the disaster, when you are not able to use rental assistance due to a lack of available housing resources.
- Funds for hazard mitigation assistance to help eligible homeowners repair or rebuild stronger, more durable homes.
- Funds for other uninsured or under-insured disastercaused expenses and serious needs.

FEMA HAZARD MITIGATION

FEMA hazard mitigation assistance provides funding for eligible long-term solutions that reduce the impact of disasters in the future. Mitigation planning and actions break the cycle of disaster damage, reconstruction, and repeated damage.

To be funded, HMGP projects must be cost effective, deliver a permanent or longterm solution, environmentally sound, and consistent with state and local hazard mitigation plan strategies.





Hazard Mitigation Grant Program Post-Fire

Wildfires can destroy homes, businesses, infrastructure, natural resources, and agriculture. They can also increase secondary hazards and leave areas prone to floods, erosion, and mudflows for many years.

FEMA's HMGP has Post-Fire assistance available to help communities implement hazard mitigation measures after wildfire disasters.

CDBG-DR grants may be allocated to help cities, counties, and entire states recover from Presidentially declared disasters.

These flexible funds focus on long-term recovery and resiliency efforts through:

- Infrastructure.
